

## Registration and Training/Certification in EMFU member countries

This table aims to provide an overview of the costs and validity of registration and training/certification requirements under the new EU legislation in each of the EMFU member countries. It will be regularly updated as more information becomes available.

*Note: an operator must register in his country of residence (or, as if from a non-EU country, in the first country where he intends to go flying), but can obtain his online theoretical competency training and certificate in any EASA country. The validity of this certificate is five years, EU-wide.*
